The NextGen UBE, developed and administered by the National Conference of Bar Examiners (NCBE), is designed to assess a comprehensive range of essential lawyering skills. It focuses on a carefully curated set of fundamental legal concepts and principles that are crucial for modern legal practice.

Currently in development, the NextGen UBE is scheduled to launch in select U.S. jurisdictions in July 2026.

### Format + Time Allocation

The NextGen UBE is nine hours long and will take place over a day and a half, with two three-hour sessions on day one and one three-hour session on day two. Each jurisdiction may choose to include state specific law component on day two or a separate day at their choosing.

The **summer exam** takes place on the **last consecutive Tuesday and Wednesday in July**, and the **winter exam** takes place on the **last consecutive Tuesday and Wednesday in February**.

#### Day 1:

- Three-hour question set
- Lunch break
- Three-hour question set

#### Day 2:

- Three-hour question set
- Lunch break (if applicable)
- Jurisdictions' local law component (if applicable)

### Question Types

The NextGen UBE will include three question formats: stand-alone multiple-choice, integrated question sets, and performance tasks.

- **Multiple-Choice Questions:** Approximately 40% of the exam will focus on stand-alone multiple-choice questions. These will feature four to six answer options, with one or more correct responses.
- **Integrated Question Sets:** Approximately 25% of the exam time will be spent on integrated question sets, which blend multiple-choice questions with short-answer responses.
- **Performance Tasks:** Approximately 33% of the exam time will be devoted to longer performance tasks. Performance tasks pose a question or series of questions about a single client matter.

### Scoring

The NextGen UBE will feature a variety of question formats (of which, sample questions can be reviewed on the NCBE website). Machine-scored items, such as multiple-choice questions, will be evaluated by the NCBE, while bar examiners in each jurisdiction will continue to grade the constructed-response questions.

These changes are significant enough to necessitate the introduction of a new scoring scale. As a result, jurisdictions will need to establish new passing scores, which have yet to be determined.

### Scoring Portability

The NextGen UBE will offer portable scores for jurisdictions that choose to recognize them. However, jurisdictions can still administer the exam without being required to accept scores from other regions.

- **Family Law:** From July 2026 to February 2028, family law concepts will be featured in every NextGen exam as part of a performance task and may also appear in integrated question sets. During this transition period, these concepts will be assessed alongside provided legal resources. Beginning in July 2028, family law will be incorporated into the foundational concepts and principles examined in the NextGen UBE. At that point, it will be tested in the same manner as other core legal principles.
- **Trusts and Estates:** Starting in July 2026 and continuing through at least February 2028, trusts and estates topics will be featured on every NextGen exam. These concepts will be assessed within performance tasks and may also appear in integrated question sets. During this time, legal resources will be provided for all trusts and estates-related questions.

MPRE

A scaled score of 75 on the MPRE is required for admission. Must take the MPRE within 25 months prior to, or 25 months after, successful bar examination.

Filing deadlines and fees

Applications must be filed by October 1st for the February exam and January 1st for the February exam. No late filing is allowed.

- Bar Exam application fee: \$575\*
- UBE score transfer or reciprocity application fee: \$875\*

\*A law student non-registration fee of \$250 is assessed to any applicant who has not previously submitted a law student registration or previously paid the non-registration fee. The law student non-registration fee is addition to the application fees

above.

Scoring

The MEE and MPT scores are scaled to the MBE, with the MBE weighted 50%, the MEE 30% and the MPT 20%. A total scaled score of 260 or higher is required to pass.

Reciprocity

Acceptance of MBE score

Applicants may transfer an MBE scaled score of at least 140 achieved in another jurisdiction if taken within 25 months prior to the next scheduled exam. Applicant must have passed the bar exam and be admitted to practice in the transferring jurisdiction.

Carryover of MBE score

An applicant who has failed the bar exam in Alabama but achieved a scaled score of at least 140 on the MBE, may carryover that MBE score to a future exam within 25 months of earning that score.

Carryover of Written Test Score

An applicant who has failed the bar exam in Alabama but achieved a scaled score of at least 140 on the MEE and MPT, may carryover that MEE/MPT score to a future exam within 25 months of earning that score.

Admission on motion

A member in good standing of another U.S. state or territory may be admitted on motion if applicant has engaged in active practice of law for five of the six years preceding application. Additional requirements apply.

Admission by UBE score transfer

Applicants who have obtained a scaled score of at least 260 on a Uniform Bar Exam taken in another jurisdiction may apply for admission based on that score. The admission of the applicant must be finalized within 25 months of the date the transferred score was earned. Additional requirements apply.



### Additional information

Before being admitted to the practice of law in Alabama, all applicants shall complete an online course on Alabama law. The course consists of eight (8) online learning modules covering the following subjects: Alabama Constitution; Alternative Dispute Resolution; Civil Litigation; Criminal Law; Family Law; Real Property; Torts; and Wills & Trusts/Probate. Bar Examination applicants will be given access to the course approximately 7 – 10 days after administration of the bar examination.

Admission on motion

A member in good standing of a reciprocating jurisdiction may be admitted on motion if applicant has engaged in active practice of law for five of the seven years preceding application. Additional requirements apply.

Admission by UBE score transfer

Applicants who have obtained a scaled score of at least 270 on a Uniform Bar Exam taken in another jurisdiction within the preceding five years may apply for admission based on that score. Additional requirements apply.

Acceptance of MBE score

Arizona does not accept an MBE score from an exam taken in another jurisdiction.

Admission on motion

A member in good standing of a reciprocating jurisdiction may be admitted on motion if applicant has engaged in active practice of law for three of the five years preceding application. Additional requirements apply.

Admission by UBE score transfer

Applicants who have obtained a passing scaled score on a Uniform Bar Exam taken in another jurisdiction within the preceding five years may apply for admission based on that score. The passing score required is 273 for exams taken prior to July 2023, and 270 for exams taken July 2023 or later. Additional requirements apply.

Additional information

All applicants must take the Arizona Law Course prior to admission. The course includes approximately six hours of video instruction along with supplemental materials and knowledge checks.

The typical timely filing deadline for applications is November 1st for the February exam and April 1st for the July exam. Late filing is typically allowed, with additional fees, until January 1st for the February exam; and June 1st for the July exam.

- Attorney exam application fee: \$1,500
- First late filing fee: \$50
- Final late filing fee: \$250
- Application for determination of moral character: \$745

Scoring

The multiple-choice score is 50% of the total score, while the written portion accounts for the other 50%. A passing score of 1,390 or greater on a 2,000-point scale is required based on the combined scores of the California Performance Test, the essay questions, and the 200-question multiple-choice exam.

Reciprocity

Acceptance of scores from other jurisdictions

California does not accept scores from an exam taken in another jurisdiction.

Admission on motion

California does not provide for admission on motion. Examination is required of all applicants. Attorneys who have been licensed in another jurisdiction for four years may be eligible to sit for the attorney exam (written exam only).

Additional information

**Admission by UBE Score Transfer**

Applicants who have obtained a scaled score of at least 270 on a Uniform Bar Exam taken in another jurisdiction within the preceding three years may apply for admission based on that score. Passing UBE scores earned more than three years, but less than five years prior may qualify if applicant has been actively engaged in the practice of law for at least two years immediately preceding the application. Additional requirements apply.

Colorado requires exam applicants to take a six-hour “Practicing with Professionalism” course prior to admission to the bar. On-motion and UBE Score transfer applicants must complete the course on professionalism within six months following admission.

The MEE and MPT scores are scaled to the MBE, with the MBE weighted 50%, the MEE 30% and the MPT 20%. A total scaled score of 270 or higher is required to pass.

**Reciprocity****Acceptance of MBE score**

Applicants may transfer any MBE scaled score achieved in another jurisdiction if taken within 13 months of the current exam, provided the applicant successfully completed the entire bar examination in the other jurisdiction.

**Admission on motion**

Applicants may be admitted without exam from jurisdictions with admission standards substantially equivalent to those of West Virginia. Applicant must have engaged in active practice of law for five of the seven years immediately preceding application and must have held a valid license to practice law from some state throughout such five year period. Additional requirements apply.

**Admission by UBE score transfer**

Applicants who have obtained a scaled score of at least 270 on a Uniform Bar Exam taken in another jurisdiction within the preceding three years may apply for admission based on that score. Additional requirements apply.

The Wisconsin Bar Exam is a two-day exam.

<b>Mandatory registration</b>	On the Monday before the examination, applicants are required to attend a mandatory registration.
<b>Day one</b>	The exam may include parts of the Multistate Essay Examination (MEE) and the Multistate Performance Test (MPT) and may also include questions prepared by the Wisconsin Board of Bar Examiners.
<b>Day two</b>	Multistate Bar Exam (MBE), a 200-question, multiple-choice exam (100 questions in the a.m., 100 questions in the p.m.).

### Subjects tested

#### MBE subjects

Constitutional Law, Contracts/Sales, Criminal Law/Procedure, Evidence, Federal Civil Procedure, Real Property, Torts

#### Wisconsin essay subjects

The essay portion of the Wisconsin bar examination may include parts of the Multistate Essay Examination (MEE), and Multistate Performance Test (MPT) both of which are prepared by the NCBE. It may also include questions prepared by the Wisconsin Board of Bar Examiners.

Agency and Partnership, Business Organizations (Corporations, Partnerships, Associations and Sole Proprietorships), Civil Procedure (Pleading and Practice, and Jurisdiction of Courts), Commercial Law (including Sales, Secured Transactions, and Negotiable Instruments), Conflicts of Laws, Family Law (Domestic Relations), Limited Liability Companies, Professional Responsibility (Ethics and Legal Responsibilities of the Profession), Taxation (Federal), Trusts & Estates plus all MBE subjects.

#### MPRE

The MPRE is not required for admission to Wisconsin bar.

### Filing deadlines and fees

Timely applications must be filed by December 1st for the February exam and by May 1st for the July exam. Late application deadlines, with an additional fee, are January 1st for the February exam and June 1st for the July exam.

- Bar exam application fee: \$450
- Late filing fee: \$200
- Admission on motion: \$850

### Scoring

The written portion is scaled to the MBE with the MBE weighted 50%. The written component of the exam may include performance on the MPT, the MEE, and/or locally developed essay questions. The composition and weight of these subcomponents may vary by exam administration. A total scaled score of 258 or higher is required to pass.

### Reciprocity

#### Acceptance of MBE score

Applicant may transfer scaled MBE score of at least 135 if within 37 months and from a successful exam taken no more than 60 days before the J.D. was conferred.

#### Admission on motion

A member in good standing of another U.S. state or territory may be admitted on motion if applicant has engaged in active practice of law for three of the five years preceding application. Additional requirements apply.

### Additional information

Applicants may take exam prior to graduation if degree received within 60 days after exam.

#### Admission by diploma privilege

Under diploma privilege, graduates of the University of Wisconsin Law School and Marquette University Law School are admitted to the practice of law by complying with the terms of SCR 40.03—their school certifies their legal competence and the Board of Bar Examiners certifies their character and fitness for the practice of law. Additional requirements apply.

Applicants who have obtained a scaled score of at least 270 on a Uniform Bar Exam taken in another jurisdiction within the preceding three years may apply for admission based on that score. Additional requirements apply.

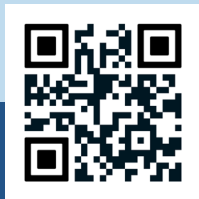
